\$50,001 to \$100,000 \$540.00 for the first \$50,000 plus \$6.45 for each add'l \$1,000 or fraction

\$100,001 and up \$863.00 for the first \$100,000 plus \$4.80 for each add'l \$1,000 or fraction

PLAN REVIEW* (to be paid at time of submittal):

65% of construction permit fee (\$48.75 minimum fee)

ELECTRICAL PERMIT** (a separate application is required):

Sign lighting \$ 65.00
